- Conduct litigation as sole attorney, including drafting the complaint and subsequent briefs, engaging in motion practice, identifying and preparing witnesses, taking testimony and conducting cross-examination.
- Conduct closed and open-record legal appeals before the San Juan County Hearing Examiner, Growth Management Hearings Board, Shorelines Hearings Board, Pollution Control Hearings Board, and state courts.
- Cultivate new allies and collaborate effectively with partners.
- Assist with communications, fundraising, and outreach activities.
- Review contracts and review and update internal policies.
- Draft articles for Friends' outreach, including website, facebook page, Annual Report, and Newsletters.
- Draft press releases for advocacy programs and serve as spokesperson as needed.
- Communicate with Board and sub-committees as needed to ensure proper oversight of Friends' advocacy efforts.
- Supervise 1-2 legal interns each summer.
